NOTICE

ALL PERSONS ARE SUBJECT TO FURTHER QUESTIONING AND THEIR PERSONAL BELONGINGS, AND CONVEYANCE ARE SUBJECT TO SEARCH.

PERSONAL PASSENGER EXEMPTIONS

All passengers arriving in the Turks & Caicos Islands who are aged 17 years or over may bring with them, free of import duty, the following items.

1. One liter of spirits OR two liters of wine (less than 40% by Volume)
EITHER 200 cigarettes
OR 100 cigarillos
OR 50 cigars
OR 250 grammes of smoking tobacco
50 grammes of perfume OR 0.25 litres of eau de toilette.

2. **OTHER GOODS/MERCHANDISE**

RESIDENTS: Residents residing permanently in the Turks & Caicos Islands are entitled to a duty free exemption of U.S. \$400.00 on those goods purchased or obtained abroad for their personal or household use, provided that the goods are neither prohibited nor restricted nor for commercial purposes.

GOODS IMPORTED FOR COMMERCIAL PURPOSES MUST BE DECLARED ON MERCHANDISE IN BAGGAGE FORM.

VISITORS/NON-RESIDENTS: other dutiable goods, purchased or otherwise obtained outside the Island, to a total value not exceeding U.S. \$400.00 per person, together with items of a personal nature for use during a temporary stay and which will be re-exported at the end of the stay, provided that the goods are neither prohibited nor restricted nor for commercial purposes.

GOODS IMPORTED FOR COMMERCIAL PURPOSES MUST BE DECLARED ON MERCHANDISE IN BAGGAGE FORM.

GOODS IMPORTED FOR COMMERCIAL PURPOSES CAN BE DEFINED AS ARTICLES FOR SALE, FOR SOLICITING ORDERS, OR OTHER GOODS NOT CONSIDERED PERSONAL EFFECTS OF THE TRAVELLER.

PROHIBITED OR RESTRICTED GOODS INCLUDE:

- CONTROLLED DRUGS AND UTENSILS USED THEREWITH.
- Firearms, ammunition and explosives (including fireworks) unless accompanied by a valid license, signed by the commissioner of Police.
- Obscene items or pornographic literature, films or videotapes.

THIS LIST IS NOT EXHAUSTIVE. IF IN DOUBT, ASK A CUSTOMS OFFICER.

ATTEMPTS TO IMPORT ANY PROHIBITED ITEMS CAN RESULT IN PROSECUTION, THE IMPOSITION OF FINES AND/OR IMPRISONMENT, AND SEIZURE OF THE GOODS.

CASH OR NEGOTIABLE INSTRUMENTS

The transportation of cash or negotiable instruments regardless of the amount is legal. However if you take out or bring into the Turks and Caicos Islands more than \$10,000.00 (U.S. or foreign equivalent, or a combination of the two) in coin, currency or negotiable instruments such as a draft or bill of exchange, debenture bonds of a company, script certificates to the bearer for shares or share warrants to the bearer, you are required by LAW to declare all to Customs.

Failure to declare the TOTAL amount you are carrying may lead to seizure of all the cash or negotiable instruments and may subject you to legal proceedings and/or criminal prosecution.
